2006/... Cese de la labor de la Comisión

La Comisión de Derechos Humanos,

Recordando la resolución 60/251 de la Asamblea General, de 15 de marzo de 2006, por la que se creó el Consejo de Derechos Humanos, y la resolución 2006/2 del Consejo Económico y Social, de 22 de marzo de 2006,

1. *Toma nota* de la resolución 60/251 de la Asamblea General, de 15 de marzo de 2006;
2. *Remite* en consecuencia todos los informes al Consejo de Derechos Humanos para que prosiga el examen de éstos en su primer período de sesiones, en junio de 2006 (véase el anexo);

3. *Expresa su reconocimiento* a todos los que contribuyeron a la promoción y la protección de los derechos humanos durante sus 60 años de existencia;

4. *Decide* dar por concluida su labor de conformidad con la resolución 60/251 de la Asamblea General, de 15 de marzo de 2006, y la resolución 2006/2 del Consejo Económico y Social, de 22 de marzo de 2006.
