The Indonesia Center for Ethics (ICE) promotes research, education and public disclosure about ethics in business, environment, government, and public life in Indonesia. ICE examines current and emerging ethical issues and promotes ethical behaviour in the public and private sectors. ICE has worked with numerous human rights-focused NGOs in Indonesia to increase public and corporate awareness of corruption and support the adoption of ethical business and government policies and practices.

Since January, 2010, ICE has concentrated on the adoption of the Voluntary Principles on Security and Human Rights (VPSHR). ICE works with NGOs and companies as well as government to raise awareness of VPSHR, carry out applied research, and provide training. ICE has established a working group and formed the champions of VP consisting prominent Indonesian figures. In this endeavour, ICE is the lead implementing NGO and facilitator of the VPSHR Working Group and was successful in assisting the Government of Indonesia to submit in a Letter of Intent (LOI) to the International Secretariat of VPSHR and drafting the Presidential Decree on VPSHR Indonesia.

The objective of this project was to promote human rights education in universities/schools and ensuring human rights curriculum in universities and high schools in Indonesia. Four main activities were completed:

- Researched and published a hand book on human rights issues with conceptual analysis and case studies in Indonesia to be used in universities and schools;
- Organized a national conference human rights education with academic leaders, teachers, NGOs, local/national government agencies, religious and ethnic groups;
- Organized the Human Rights Essay Award and training for high school and university students.
- Media releases and press conferences.
- + Women For Peace Project (2007) supported by The Embassy of Norway in Indonesia.

The objective of this project was to raise awarenes of SR 1325 (The United Nations unanimously adopted Security Council Resolution 1325 on Women, Peace and Security in October 2000). The project creates an international dialogue and between NGOS and GO to realize sustainable peace and engaging both of men and women. Media campaign is a big part of this project to carry out the message that peace is not only the absence of war, violence and hostilities, but also the enjoyment of economic and social justice, equality and the entire range of human rights and fundamental freedoms within the society. This conference was attended by women in conflict areas such as from Aceh, Papua and victims of past human rights violations.

 - "Women in Conflict Areas" (2002), supported by DAI/USAID. 60 minute film which explores the problems of women in conflict areas such as Aceh, Poso and Papua. The survivors tells their stories on trauma, sexual harassment, abuse and the feeling of insecurity. Segment of Papua contains stories of women and children living with HIV/AIDS.
 - "Women and Children for Sale" (2003), supported by USAID.60 minute film covering the stories of children being trafficked in West Kalimantan, Batam and Malaysia. This film has been shown in national and International film festivals, and used as training kit for NGOs and the police department in Indonesia.

Dear Search Committee,

Enclosed please find my curriculum vitae to apply to become a member of the UN Working Group on Business and Human Rights. I am applying for this position because I believe I can make a substantial contribution to the efforts to develop and improve knowledge and application of human rights in the business world. I also feel I have the appropriate skills and qualifications pertaining to human rights issues and I have a strong work ethic, drive for results, and knowledge of the South East Asia region especially Indonesia. Some of the specific qualifications that I would bring to the assignment are outlined below.

First, I have a strong background working with both non-government and government agencies as well as with companies on business and human rights issues. In 2008, I founded and continue to direct the Indonesia Center for Ethics (ICE), a non-profit organization that promotes research, education and public disclosure about ethics in business, environment, government, and public life in Indonesia. ICE examines current and emerging ethical issues and promotes ethical behavior in the public and private sectors. ICE has worked with numerous human rights-focused NGOs in Indonesia to increase public and corporate awareness of corruption and support the adoption of ethical business and government policies and practices. In 2009, ICE worked specifically on introducing the Voluntary Principles on Human Rights and Security (VPSHR) in Indonesia. After working on a scoping study in November 2009-January 2010, ICE formed Indonesia's first working group on VPSHR comprising representatives from governments, NGOs and the private sector (three pillars). In this project, I have chaired and directed the VPSHR monthly round table meetings with companies, NGOs and Government, research and publication on VPSHR Indonesia and worked with the Government of Indonesia in processing and drafting the Letter of Intent (LOI) and Presidential Decree on VPSHR. Among other responsibilities, my main task was to work with and convince national and transnational companies in the extractive industries to work together with government and civil society on VPSHR. This exercise has benefited Indonesia tremendously in the area of business and human rights especially in building trust.

Second, I have an extensive experience on women's human rights issues. Following my academic work at the EHESS in Paris, France, I founded Yayasan Jurnal Perempuan (YJP), an NGO in Indonesia that focuses on issues such as violence against women, trafficking of women and children, and gender and development in Aceh and Papua. I secured financing for and led several projects, including raising awareness about trafficking of women and children and I worked with global and local media on advocacy on the issue. On this project, I worked closely and networked with NGOs and government to push Indonesia's anti-trafficking law into effect. Through YJP I have also worked with Indonesian Government agencies such as the Ministry of Women's Affairs and the National Police Force, for whom I conducted training on human rights.

Third, I have strong academic and research skills. In 2004, in my capacity as Program Director for Human Rights in the Department of Philosophy, Faculty of Humanities, University of Indonesia, I have led a program focusing on human rights education at the universities and high schools of Indonesia. The program includes researching cases of human rights abuse in Indonesia and writing and publishing text books for university and high school students.

In 2006, I was assigned by the University to work on promoting implementation of UN Security Council Resolution 1325 on Women, Peace and Security (SR 1325). SR 1325 commits members to making women's participation in peacemaking and peace building central to its activities. I organized an International conference on the issue and included East Timor in the conference. Later in 2009, I was invited by the Alola Foundation in East Timor to participate in their work on building peace and promoting human rights.

I strongly believe I can contribute substantively to fulfilling the mandate of the Working Group on Business and Human Rights, and I would find it professionally and personally exciting to work and to learn with this talented and motivated group. While my experience and research skills are important, I believe my strongest assets are my professional ethics and my passion for human rights issues.
