

### INFORMATION NOTE

Subject: Human Rights Council resolution 10/7 - "Human Rights of Persons with Disabilities: National Frameworks for the Promotion and Protection of the Human Rights of Persons with Disabilities"

The Office of the United Nations High Commissioner for Human Rights has the honour to refer to the Human Rights Council Resolution 10/7, entitled "Human Rights of Persons with Disabilities: National Frameworks for the Promotion and Protection of the Human Rights of Persons with Disabilities".

On 10 July 2009, the Office of the High Commissioner forwarded a note verbale to all Permanent Missions to the United Nations Office at Geneva requesting information concerning:

- a) The existence, structure and mandate of focal points within Government appointed with responsibility for matters related to the implementation of the Convention (article 33, paragraph 1);
- b) The existence, structure and mandate of coordination mechanisms within Government to facilitate action related to the implementation of the Convention (article 33, paragraph 1);
- c) The existence, structure and mandate of national frameworks tasked with promoting, protecting and monitoring implementation of the Convention, with particular reference to how the principles relating to the status and functioning of national human rights institutions for the promotion and protection of human rights are taken into account in such frameworks (article 33 paragraph 2);
- d) The process regulating involvement and participation of civil society and in particular persons with disabilities and their representative organizations in the national implementation and monitoring process (article 33, paragraph 3);
- e) The existence, structure and mandate of independent authorities tasked with monitoring facilities and programmes designed to serve persons with disabilities to prevent exploitation, violence and abuse (article 16, paragraph 3).

The Office of the High Commissioner for Human Rights has the pleasure to extend the deadline for submissions and would be grateful if any information in response to the note verbale could be sent to the Office of the United Nations High Commissioner for Human Rights (United Nations Office at Geneva, CH 1211 Geneva 10; Fax: +41 22 917 90 08; E-mail: registry@ohchr.org) by 23 September 2009. Please indicate whether the information provided can be made available on the OHCHR website.

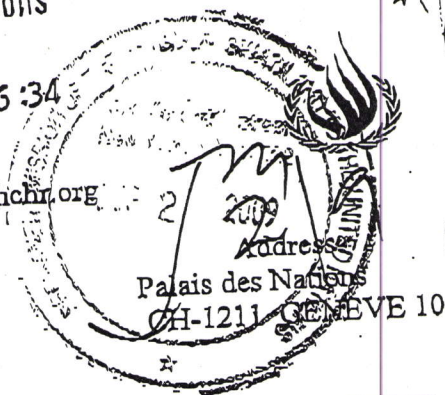
